### Section 1 – Target Market and Product Features

**An investor who satisfies the following is in the target market for the Fund:**

- wants to invest in a portfolio that's diversified across markets, growth assets, investment managers, and securities;
- wants the Fund's manager to actively adjust the portfolio to take advantage of opportunities to provide better returns, or less risk, than those generated by the investment markets the portfolio invests in;
- wants long-term capital growth and therefore seeks an investment that invests in growth assets (primarily shares);
- understands there can be very large fluctuations in income and the value of your investment; and
- who wants to invest either:
  - indirectly, through MLC MasterKey Investment Service or another 'platform product' we approve (such as an investor-directed portfolio service); or
  - directly, by application to us provided the investor currently holds an investment in a MasterKey Unit Trust fund.

Significant product change	We make a significant change to the Fund.
Fund performance	The Fund has significantly and persistently not achieved its investment objective.
Significant breach	We commit a significant breach of financial services law where the breach relates to the design or distribution of the Fund.
Significant dealings outside of TMD	We identify significant dealings outside of the TMD.
Complaints from investors and distributors	We receive a significant and unexpected number of complaints, in respect of one or more calendar quarters, in relation to the Fund's design (including its features, terms or conditions) or the manner in which the Fund is distributed.
Notification from ASIC	We receive a notification from ASIC raising serious concerns regarding the design or distribution of the Fund.

<p>Other information requested by us</p>	<p>Other information reasonably requested by us to meet our legal obligations, with appropriate notice given to the Distributor such as:</p> <ul style="list-style-type: none"> <li>• a summary of the steps taken to ensure the Distributor's conduct is consistent with this TMD (as required under section 994E(3) of the Corporations Act); and</li> <li>• feedback on investor experience with the Fund which suggests that the TMD may no longer be appropriate.</li> </ul>
